- Monthly payments are due the 1st week of each month, September-May. There are no tuition discounts for partial months or student absence for any reason.
- A \$100 nonrefundable fee is due at time of registration. This includes a supply fee in place of the student bringing his/her own supplies to school.
- All payments can be made by cash, check (payable to Tallmadge Lutheran Church). A \$25 fee is charged for any checks returned NSF.
- Year in full payments receive a 5% discount and are due by the end of the first week of school in September.
- Families with multiple students enrolled at TCP pay full tuition on 1st/oldest student, then received a 20% discount on tuition on additional students. No discounts are given on Registration Fee and Supply Fee.
- In the event of withdrawal from the preschool, please give the director 2 weeks notice. Full tuition is required for the month of withdrawal.
- If the director of the center feels a student cannot adjust to the center's program and/or code of behavior, a student may be disenrolled. Full tuition is required for the month of dismissal.
- The director has the authority to put a hold on student attendance if the tuition account is two months in arrears. The student may return to the preschool once the account is made current or suitable arrangements have been made with the director.

I hereby acknowledge that, in the care of children, accidents can occur even if reasonable care and supervision is provided.
